EXAMINATION SCHEDULING PROCEDURES

The Office of Court Administration in conjunction with the Texas Department of Licensing and Regulation will administer the examinations via PSI until August 31, 2015. For eligibility and licensing information, please contact:

Upon approval of eligibility, you will receive an email confirmation with instructions for scheduling an appointment to take the examination. (If you have not provided an email address, you will receive a postcard via U.S. Mail with this information).

EXAMINATION FEES ARE NOT REFUNDABLE OR TRANSFERABLE. Your examination fee will be forfeited if you do not test within 1 year of the date your examination fee is received by PSI.

INTERNET REGISTRATION

For the fastest and most convenient test scheduling process, PSI recommends that candidates register for their examinations using the Internet. In order to register over the Internet, candidates will need to have a valid credit card (Visa, MasterCard, American Express or Discover). Candidates register online by accessing PSI's registration website at www.psiexams.com. Internet registration is available 24 hours a day. In order to register by Internet, complete the steps below:

- Log onto PSI's website and create an account. Please enter your email address and first and last name. This information must match exactly with the information PSI has on file. Be sure to check the box next to "Check here to attempt to locate existing records for you in the system"
- You will be asked to select the examination and enter the ID# that PSI provided to you. Your record will be found and you will now be ready to pay and schedule for the exam. Enter your zip code and a list of the testing sites closest to you will appear. Once you select the desired test site, available dates will appear. If you have problems contact PSI at (800) 733-9267 for help.

TELEPHONE REGISTRATION

For telephone registration, you will need a valid credit card (Visa, MasterCard, American Express or Discover).

PSI registrars are available at (800) 733-9267, Monday through Friday between 6:30 am and 9:00 pm, and Saturday-Sunday between 8:00 am and 4:30 pm, Central Time, to receive your payment and schedule your appointment for the examination.

CANCEL OR RESCHEDULE AN EXAMINATION APPOINTMENT

You may cancel and reschedule an examination appointment without forfeiting your fee if your cancellation notice is received 2 days before the scheduled examination date. For example, for a Monday appointment, the cancellation notice

would need to be received on the previous Saturday. Please use the PSI Website or call PSI at (800) 733-9267.

Note: A voice mail message is not an acceptable form of cancellation. Please use the PSI Website or call PSI and speak directly to a Customer Service Representative.

MISSED APPOINTMENT OR LATE CANCELLATION

Your registration will be invalid, you will not be able to take the examination as scheduled, and you will forfeit your examination fee, if you:

- Do not cancel your appointment 2 days before the schedule examination date;
- Do not appear for your examination appointment;
- Arrive after examination start time;
- Do not present proper identification when you arrive for the examination.

SPECIAL EXAMINATION ARRANGEMENTS

All examination centers are equipped to provide access in accordance with the Americans with Disabilities Act (ADA) of 1990, and every reasonable accommodation will be made in meeting a candidate's needs. Applicants with disabilities or those who would otherwise have difficulty taking the examination must fill out the form at the end of this Candidate Information Bulletin and fax to PSI (702) 932-2666. This form also includes out-of-state testing requests.

FOREIGN LANGUAGES FOR THE WRITTEN EXAMINATION ONLY

For languages other than English, you may request to have the examination translated by contacting PSI and paying an additional cost for each translation, or you may bring a bound Word-to-Word translation dictionary. The dictionary cannot contain pictures or definitions. Candidates are not permitted to bring in any additional papers (loose or attached) with their dictionary. Highlighting, underlining, indexing or marking in the dictionary prior to or during the examination is prohibited. Any candidate caught writing, highlighting, underlining, and or indexing in the dictionary during the examination will be subject to forfeiting their dictionary, termination of their examination and reporting the incident to the Texas Department of Licensing and Regulation.

EXAMINATION SITE CLOSING FOR AN EMERGENCY

In the event that severe weather or another emergency forces the closure of an examination site on a scheduled examination date, your examination will be rescheduled. PSI personnel will attempt to contact you in this situation. However, you may check the status of your examination schedule by calling (800) 733-9267. Every effort will be made to reschedule your examination at a convenient time as soon as possible.

REPORTING TO THE EXAMINATION SITE

On the day of the examination, you should arrive 30 minutes prior to your scheduled appointment time. This allows time for sign-in and identification verification. NO conversing or any other form of communication among candidates is permitted once you enter the <u>examination area</u>.

If you arrive late, you will NOT be admitted to the examination site and you will forfeit your examination registration fee.

REQUIRED IDENTIFICATION AT EXAMINATION SITE

You must provide 1 form of identification. The identification must be a VALID form of government-issued identification for example, driver's license*, state ID, or passport, which bears your printed name, photograph, signature, date of birth, and expiration date. Identification provided must match all information provided to PSI upon eligibility. If your ID does not contain the required information, you may be asked to provide other forms of valid identification to confirm your identity. A digital copy of your identification documentation will be taken upon check in, and stored with your personal data.

*An expired driver's license will be accepted <u>only</u> if accompanied by a VALID Texas Department of Public Safety temporary permit. Likewise, the temporary permits must be accompanied by the expired DPS driver's license.

If you cannot provide the required identification, you must call (800) 733-9267 at least 3 weeks prior to your scheduled appointment to arrange a way to meet this security requirement. Failure to provide the required identification at the time of the examination without notifying PSI is considered a missed appointment, and you will not be able to take the examination and will forfeit your examination fee.

SECURITY PROCEDURES


The following security procedures will apply during the examination:

- While at a PSI examination site, you are considered to be a professional and shall be treated as such. In turn, you must conduct yourself in a professional manner at all times. While at the site, you shall not use words or take actions that are vulgar, obscene, libelous, or that would denigrate the PSI staff or other candidates. You must adhere to all policies and standards to ensure that all candidates have a pleasant and professional examination experience. If you fail to comply with these policies, you will have your examination results disqualified and will forfeit your examination fee.
- NO conversing or any other form of communication among candidates is permitted once you enter the <u>examination</u> area.
- Cell phones, pagers, PDAs, cameras, notes, electronic devices, and recording devices, of any kind are NOT allowed to enter PSI examination sites. Additionally, guest visitors and/or family members are not allowed at the examination site. NO personal items are to enter the examination site. A locker will be provided to store a

- few small items. PSI will not be responsible for any personal items, and suggests that you leave such items in another safe place, of your choosing
- Only non-programmable calculators that are silent, battery-operated, do not have paper tape printing capabilities, and do not have a keyboard containing the alphabet will be allowed in the examination site.
- No smoking, eating, or drinking will be allowed at the examination site.
- Copying or communicating examination content is a violation of PSI security policy and Texas State Law. Either one may result in the disqualification of examination results and may lead to legal action.

COMPUTER-BASED WRITTEN EXAMINATION

Taking the PSI examination by computer is simple. You do not need any computer experience or typing skills. You will use fewer keys than you use on a touch-tone telephone. All response keys are colored and have prominent characters. An illustration of the special keyboard is shown here. You may also use the mouse.



IDENTIFICATION SCREEN

You will be directed to a semi-private examination station to take the examination. When you are seated at the testing station, you will be prompted to confirm your name, identification number, and the examination for which you are registered.

TUTORIAL

Before you start your examination, an introductory tutorial to the computer and keyboard is provided on the computer screen. The time you spend on the tutorial, up to 15 minutes, DOES NOT count as part of your examination time. Sample questions are included following the tutorial so that you may practice using the keys, answering questions, and reviewing your answers.

One question appears on the screen at a time. During the examination, minutes remaining will be displayed at the top of the screen and updated as you record your answers.

EXAMINATION QUESTION EXAMPLE

During the examination, you should press 1, 2, 3, or 4 to select your answer or press "MARK" to mark it for later review. You should then press "ENTER" to record your answer and move on to the next question. A sample question display follows.



IMPORTANT: After you have entered your responses, you will later be able to return to any question(s) and change your response, provided the examination time has not run out.

EXAMINATION REVIEW

While taking the examination, examinees will have the opportunity to provide comments on any questions, by using the comment key on the keyboard. These comments will be analyzed by PSI examination development staff. Although PSI does not respond to individuals regarding these comments, all substantive comments are reviewed. If a discrepancy is found during the comment review, PSI and the department may reevaluate candidate results and adjust them accordingly. This is the only review of the written examination available to candidates. There is NO review of the Oral examination.

Stay on Ridgecrest until you come to the red brick office complex on the left side corner of Ridgecrest and Teckla. 4312 is the 3rd building facing Teckla. Ste 500 is the end suite on the North side of the building.

From Canyon, take Bell St exit and go North to traffic light at 45^{th} St and turn right. Turn left at the 2^{nd} traffic light to Teckla.

If Northbound on IH 35 exit at Hwy 2222 and stay on the I-35 service road to the light at Hwy. 290 E. Take a right at the traffic light onto the 290 E. service road. Take a left at the first traffic light onto Cameron Road. Go through the light and the examination site is in the business park on the left, Ste. F-111.

Examination Reference Material and Content Outlines

Licensed Court Interpreters must take written and oral examinations which are developed by the <u>Consortium for State Court Interpreter Certification</u> part of the National Center for State Courts. The written examination measures the candidates' English comprehension and knowledge of court terms. The oral examination measures the candidates' interpreting skills and is given at one sitting in three parts which are recorded.

EXAMINATION DESCRIPTION

Part 1 - Sight Interpretation

You will be given six minutes to review and interpret a typewritten page from English into the target language.

You will be given six minutes to review and interpret a typewritten page from the target language into English.

The exercises outlined below will help you develop skills in sight translation. Practice them in all your working languages.

Part 2 - Consecutive Interpretation

You will be given **22 minutes** to complete this portion of the exam. This part of the examination is administered as a role-play of the questioning of a witness by a lawyer.

The consecutive portion will simulate a trial setting in which an English-speaking attorney asks questions of a witness speaking in their targeted language. The candidate will be the interpreter from English to the targeted language and from the targeted language back to English. Parts of this portion of the examination always include examples of lower register speech, including profanity and idiomatic usage.

Consecutive interpreting requires intense listening of a few sentences followed by an accurate interpretation of what was said. The interpreter will often take notes to help in the interpreting process, especially if the utterances are long. Consecutive interpreting is usually bi-directional between two languages, for example interpreting Spanish to a listener in English and then interpreting the English reply back into Spanish.

Part 3 - Simultaneous interpretation

This part of the examination is 8 minutes long and requires the candidate to listen to and simultaneously interpret a recorded speech of a Lawyer. The candidate wears a set of headphones to listen to the recording and speaks aloud so that her or his performance can be recorded.

The speech is entirely in English, and the interpreter interprets into the target language as would be required to assist a defendant during a trial that only speaks the target language.

EXERCISES TO AID INTERPRETERS

Reading Aloud

Stand in front of a mirror and read passages aloud from any book, newspaper, or magazine. A legal textbook, code book, or other legal text is useful for familiarizing yourself with legal language. Record or videotape yourself and analyze the



outcome critically. Pay attention to your voice, pitch, tone, hesitations, signs, projection, enunciation, and posture.

Controlling Emotions

Practice controlling your emotions while reading aloud texts with high emotional content, such as fear, anger, humor, etc. Make sure you convey the author's intended emotions and not your personal reaction to the subject matter.

Public Speaking

Practice speaking before a group of people at every opportunity. People you know will constitute a less threatening audience and will allow you to ease your way into public speaking and build your confidence. Court interpreting is an ongoing exercise in public speaking.

Extensive Reading

Build up your reading speed and your vocabulary by reading as much as possible in many different fields.

Analyzing

Analyze the content of each text and practice picking out the subject and verb to determine the core meaning.

Example: Although less influential than in Argentina, migration from Europe in the late nineteenth and early twentieth centuries affected the development of Chilean political culture. Subject: migration; Verb: affected.

Simultaneous Skills

The following exercises are designed specifically to build the dual tasking skills involved in simultaneous interpreting. They should be practiced daily for about a half hour at a time. Simultaneous interpreting skills must be acquired over time to allow for maximum familiarity.

First

Have someone record passages from magazines or newspapers on tape, or record radio or television talk shows or interview programs (news broadcasts are not suitable for these exercises because the pace is too fast and the content is too dense). The subject matter of these passages is irrelevant, but it should not be too technical or contain too many statistics and proper names. Essays and opinion columns are good sources of texts for recording. As you play back the tape, "shadow" the speaker: repeat everything the speaker says verbatim. Try to stay further and further behind the speaker, until you are lagging at least one unit of meaning behind.

Second

Once you feel comfortable talking and listening at the same time and are not leaving out too much, begin performing other tasks while shadowing. First, write the numerals 1 to 100 on a piece of paper as you repeat what the speaker says (make sure you are writing and speaking at the same time, not just writing during pauses). When you are able to do that, write the numerals in reverse order, from 100 to 1. Then write them counting by 5s, by 3s, and so on. Note what happens whenever numbers are mentioned in the text you are shadowing.

Third

When you are able to do exercise 2 with minimal errors, begin writing out words while shadowing. Begin with your name and address, written repeatedly. Then move on to a favorite poem or a passage such as the preamble to the U.S. Constitution (always choose a passage in the same language as that which you are shadowing). When writing this text, you should copy from a piece of paper placed in front of you. Do not try to write the passage from memory while shadowing the tape.

Fourth

While shadowing the tape as in the previous exercises, write down all the numbers and proper names you hear. Then play the tape back and check to see if you wrote them correctly.

ORAL SCORE REPORTING

Your oral examination will be graded at the next grading session for this language. Please do NOT contact PSI for your examination results. PSI's role is only to administer the oral examination. PSI will not have any information regarding your oral examination score. Spanish examinations are graded several times a year and other languages are graded once a year. This process usually takes several weeks. Once scored, your results will be mailed to you.

LICENSE DESIGNATION

To be licensed as a court interpreter, each applicant must pass all three parts of the oral examination.

MASTER

To achieve a Master designation license, you must score at least a 70% on each part of the oral examination. The Master designation license allows you to interpret court proceedings in all state courts in this state, including justice and municipal courts.

BASIC

To achieve a Basic designation, you must score at least a 60% on each part of the oral examination. The Basic designation license will allow you to interpret court proceedings in justice and municipal courts that are not municipal courts of records, other than a proceeding before the court in which the judge is acting as a magistrate.
