EXAMINATIONS BY PSI LICENSURE: CERTIFICATION

Effective July 1, 2007, associate brokers and qualifying brokers are required to pass a Commission approved Mandatory Course examination as a condition of receiving continuing education credit for the course.

The New Mexico Real Estate Commission Mandatory Course examination will test brokers knowledge of Real Estate Commission policies and programs, recent changes to the New Mexico real estate license law and Commission rules, trust accounts, brokerage relationships and the New Mexico broker, civil rights laws, legislation other than the real estate license law affecting real estate, property management, and lessons learned from the decisions and orders issued by the commission.

EXAMINATION PAYMENT AND ACCESS PROCEDURES

EFFECTIVE JANUARY 1, 2010, YOU WILL TAKE THIS EXAMINATION ONLINE AT THE CONVENIENCE OF YOUR HOME OR OFFICE.

Following are the steps taken to purchase and take the examination electronically. You may no longer test at a PSI examination site.

- 1. Your education provider will provide your eligibility electronically to PSI.
- Upon approval you will receive an email within 2 business days with instructions on how to purchase the examination. This email will come from measuredsuccess@mccanntesting.com. It will include your username and password. You will purchase the examination at www.vantageonlinestore.com.

You will receive your score immediately following the completion of the examination. If you fail, you may retake the examination by following the same steps you did for the first examination. There is no limit to the number of times you can take the test. You will need to purchase the examination for each retake.

FREQUENTLY ASKED QUESTIONS

I received the required education and my provider imported my name to PSI, however I have not received the email. Please call the McCann Help Desk direct at 877-877-4085 or email measuredsuccess@mccanntesting.com. Your information will be verified and another email sent.

What happens if a person loses their internet connection during the test for some reason? No problem. Every answer submitted is stored, as it's submitted. Therefore, if internet connection is lost, simply log back in and access the test again. All of the answers will still be captured.

I don't have a computer. What if I need to use someone else's email address. You must provide your educator with the email address that you would like to use to access the online examination. It doesn't matter which computer you are using as long as you can get to the email address that you submitted to the educator.

Can I start the examination and just take a portion, then go back and take the rest at a later time/date. The system does NOT allow a candidate to stop the test and resume at a different time.
